CALL TO ORDER:

The Claunch-Pinto Soil and Water Conservation District (CPSWCD) regular meeting of the Board of Supervisors was called to order by Felipe Lovato, Jr., Chairman, at the Natural Resource Conservation Center Conference Room located at 1206 South HWY 55 in Mountainair, NM at 8:05 a.m.

Welcome Attendees:

The chairman welcomed those present and thanked them for taking the time to attend. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

APPROVAL/DISAPPROVAL OF AGENDA:

The board reviewed the agenda. **ACTION TAKEN**: Richard Shovelin moved to approve the agenda. William Caster seconded the motion. Motion carried unanimously.

APPROVAL/DISAPPROVAL OF MINUTES:

Minutes of the regular meeting from December 7, 2018:

ACTION TAKEN: Richard Shovelin moved to approve the minutes of December 7, 2018 as read. Larry Gomez seconded the motion. Motion carried by unanimous vote.

TREASURER'S REPORT:

The board reviewed the treasurer's report for the month of December, 2018 with accounts payable for January 2019.

ACTION TAKEN: Richard Shovelin moved to accept the treasurer's report for December, 2018 and pay the accounts payable for January, 2019. William Caster seconded the motion. Motion carried by unanimous vote.

Audit:

Richard Shovelin moved to table this item. Larry Gomez seconded the motion. The motion carried by unanimous vote.

REPORTS:

New Mexico Department of Agriculture:

Jim Wanstall's written report is included in the board packets.

Field Office Report:

The NRCS Field Office written report is included in board members' packets. Kenneth Lujan introduced Stephen Ferguson, the new soil conservation technician. He will be working in the Mountainair office. Mr. Lujan reported that the Farm Bill has been signed and there are some positive changes in it.

- About twice the amount of money for EQIP is included.
- Now acequias, land grants and ditch associations can apply for EQIP funds. Policy needs to be developed first.
- Stand-alone practices can now be funded if the project meets NRCS standards. Mr. Lujan explained the benefits to the producer.
- Another change is that the producer has to have control of the land when the contract is signed, not in advance, as previously required. He explained the reasons behind the change.
- CSP funding is still in the Farm Bill, which is good for New Mexico because the funding supports NRCS salaries.
- Seven new positions were approved for New Mexico.
- The criteria for ranking projects will remain about the same.

Richard Shovelin congratulated Mr. Lujan on the success of the Estancia FFA livestock judging team, which he coaches. The team placed second in the nation at the Western National Roundup in Denver on January 9. Mr. Lujan's son Daniel placed first nationally as a livestock judge. The team now has the opportunity to compete in England, Scotland and Ireland. The team will be working to raise the money for the trip. This opportunity is the first time in twenty years that New Mexico has qualified. Mr. Lujan will ask to be on the agenda for the next board meeting to ask the district for support.

Mr. Ferguson told the board about his background: he is from Estancia and earned a degree in wildlife science and agricultural education from New Mexico State; he worked as a government trapper and then taught agriculture.
